AND SPECIAL GENERAL BODY MEETING**

Dear ICK Community Members,

This is to notify that election of the Executive Committee (9 Members) and Board of Trustees (5 Members) of the Islamic Center of Kent, WA will be held on December 08, 2019 (Sunday) after Dhu'r prayer (at 1:00 pm) at ICK. All the voting members are hereby requested to attend the special general body meeting called for the election and participate in the election. In order for you to participate in the election, you must have to proof your identity and must be a voting member according to ICK Bylaws. However, all assembly members may attend the meeting for all other events except for the election.

Election Process and Schedule:

1. Compiling list of Voters, List to be Posted on the Notice Board & Communicated Using Website / Email / WhatsApp and Last date for enrolling into ICK membership **November 01, 2019;**
2. Candidate nomination form, General Body meeting notice, and the voters list will be posted on the ICK Notice Board and communicated (Mailed/Emailed) on **November 03, 2019;**
3. Voters will nominate themselves or their chosen voting members by mail or online through ICK website or by email to election commission by **November 13, 2019;**
4. List of nominations will be published at the ICK display board and by ICK web site on **November 14, 2019;**
5. Any nominated person will have the opportunity to withdraw their candidature in writing/email to the Election Commission by **November 16, 2019;**
6. If there is only one candidate for a particular position, he/she will be declared elected for that position;
7. If there is no nomination for a particular position, this position will be decided on the election day in the General Body meeting on **December 08, 2019;**
8. Ballot paper containing the nominated candidates and amendment proposal to the ICK By-laws/constitution will be mailed on **November 23, 2019** to each of the voting members mailing address;
9. Voters may chose to mail back their duly filled ballot paper to the Election Commission on or before **December 07, 2019** (mailed filled in ballot paper received by December 08, 2019 before 10:00 am will counted only) or voters may chose to vote physically on the election day on **December 08, 2019;**
10. Candidates for a particular position with majority votes will be declared elected for that position;
11. Decision of the Election Commission regarding nomination, validity of the nomination, withdrawal, and final declaration of the candidature will be final and non-appealable.


